Dear Colleague:

The 43rd Annual Conference on Historical and Underwater Archaeology will be held at Amelia Island Plantation, located just north of Jacksonville, Florida. Amelia Island is situated between the Atlantic Ocean and the Intracoastal Waterway, providing the perfect setting for this year's conference theme, *Coastal Connections: Integrating Terrestrial and Underwater Archaeology.* Coastal communities of all sizes provide many opportunities for archaeological discussion on current research and theoretical approaches to the coast, but also provide an opportunity to discuss archaeological responsibilities within the profession, and with the public. In addition to the educational sessions and meetings of archaeologists from around the world, the Conference will include an exhibition of products, services and publications from companies and other organizations in the archaeological community. We hope that you will join us where the land meets the sea at Amelia Island Plantation, Florida, January 6-9, 2010.

Formed in 1967, the Society for Historical Archaeology (SHA) is the largest scholarly group concerned with the archaeology of the modern world (A.D. 1400-present). The main focus of the Society is the era since the beginning of European exploration. SHA promotes scholarly research and the dissemination of knowledge concerning historical archaeology. The Society is specifically concerned with the identification, excavation, interpretation, and conservation of sites and materials on land and underwater. Geographically, the SHA emphasizes the New World, but also includes European exploration and settlements in Africa, Asia, and Oceania. SHA welcomes exhibitors who share its mission and code of ethics at the 2010 Conference on Historical and Underwater Archaeology!

The SHA will offer tabletop space in its Book Room for publications and exhibits relevant to historical and maritime archaeology. The Book Room will be located in Amelia 1 & 2 of the Amelia Island Plantation Conference Center, Amelia Island, Florida.

Exhibitors are welcome to purchase tickets for events with a fee (i.e., Thursday's Reception, Awards Banquet).

All interested vendors must complete an application/contract for exhibit space. Please be aware that *space is limited* and will be allocated on a first come, first-served basis. In the event that your preferred space is unavailable, SHA staff will call you to discuss alternate locations. Full payment must accompany your completed Exhibitor Contract to ensure processing. Once contracts are received, a confirmation packet will be sent with information concerning conference registration, shipping and electrical, and telephone connections. The SHA reserves the right to alter the floorplan or to relocate tables at its discretion.


